It is the purpose of this agreement to exempt, waive and relieve releasees from liability for personal injury, property damage, and wrongful death, including if caused by negligence, including the negligence, if any, of releasees. "Releasees" include Birmingham Rugby Club Foundation, Rugby Alabama, USA Rugby, the City of Birmingham, Alabama, and their affiliate associations, local associations, member teams, event hosts, other participants, coaches, officials, sponsors, advertisers, and each of them, their officers, directors, agents and employees.

- 1. I acknowledge and understand that there are risks associated with participation in all sports activities, including rugby, including personal injury, illness, paralysis and/or death.
- 2. I willingly assume the risks associated with participation and accept that there are also risks that may arise due to OTHER PARTICIPANTS which I also willingly assume.
- 3. I acknowledge and understand the novel Coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization, the contagious nature of COVID-19, and that I may be exposed to or infected by COVID-19 by attending any rugby activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I further understand that the risk of becoming exposed to or infected by COVID-19 at any rugby events/activities may result from the actions, omissions or negligence of myself and/or others, including, but not limited to Coaches, Referees, Trainers, Volunteers and other participants and their families.
- 4. I acknowledge and understand when participating in sports related activities including, but not limited to rugby practices, matches, tournaments, or other events, I or my dependent child or family member may be included in a photograph. I agree to allow such photos, videos, or film likenesses to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. I hereby release the photographer from all claims, demands and liabilities whatsoever in connection with the photographs. I hereby waive any right to inspect or approve any final product that uses my photographs. I acknowledge that the images may be used, without limitations, in print publications, online publications, websites, and on social media. I waive any right to royalties or other compensation arising from or related to the use of these photographs.
